If I wanted to know anything about politics, history or science, he always knew the answers about the past, understood the present and even seemed able to predict the future! He took my family to the first major league ball game. He made me laugh, and he made me cry. The stranger never stopped talking, but Dad didn't seem to mind.

Sometimes, Mom would get up quietly while the rest of us were shushing each other to listen to what he had to say, and she would go to the kitchen for peace and quiet. (I wonder now if she ever prayed for the stranger to (leave).

Dad ruled our household with certain moral convictions, but the stranger never felt obligated to honor them. Profanity, for example, was not allowed in our home - not from us, our friends or any visitors. Our long time visitor, however, got away with four-letter words that burned my ears and made my dad squirm and my mother blush.

My Dad didn't permit the liberal use of alcohol but the stranger encouraged us to try it on a regular basis. He made cigarettes look cool, cigars manly, and pipes distinguished. He talked freely (much too freely!) about sex. His comments were sometimes blatant, sometimes suggestive, and generally embarrassing.

I now know that my early concepts about relationships were influenced strongly by the stranger. Time after time, he opposed the values of my parents, yet he was seldom rebuked ... And NEVER asked to leave.

More than fifty years have passed since the stranger moved in with our family. He has blended right in and is not nearly as fascinating as he was at first. Still, if you could walk into my parents' den today, you would still find him sitting over in his corner, waiting for someone to listen to him talk and watch him draw his pictures.

#### **Annexation**

One of the key topics of discussion that has occurred in Mobile before and after the election is annexation.

The recent 2020 census has shown that Mobile has continued to lose population, a trend that has occurred since 1980. One reason is the fact that the city loses a lot of its population when young people go off to college or move away to larger cities where there are more job opportunities and activities happening there.

Another factor is that many choose to live in Baldwin County, which has been one of the fastest growing counties in the state.

Another big reason is that the city limits of Mobile haven't expanded as much as it should to keep

up with the movement of the population to the west and south of the city. The last major annexation occurred about 10 or 12 years ago under the Sam Jones administration.

There were attempts recently to annex certain areas of west Mobile, but that was defeated by the city council. A main reason put forth was the concern that the annexation would shift the racial balance of the city and dilute the black voting strength. It was also speculated that if the annexation had occurred at that time, it would have affected the outcome of the mayoral election. Given the low voter turnout in the election, if annexation had occurred, it would not have changed the outcome of the mayoral election.

I support annexation because it allows the city the opportunity to keep up with the movement of people as they seek out new housing and neighborhoods. At present, there are not very many areas to build large subdivisions within the existing city limits. Recent developments downtown and in midtown have been a plus, however, most of the big developments have occurred in Semmes, Dawes, Saraland and other areas of west Mobile. However, there are a few major tracts of land along Moffett Road, Highpoint Boulevard, and Rangeline Road that are in the existing city limits that could be developed.


Decisions made by developers determine where these developments occur. A big factor is the cost of land which is typically cheaper the further out you go. Other factors are the zoning regulations, which have been undergoing an overhaul, that may weigh into the decision-making of those developing subdivisions.


Race is another factor that plays into where housing is built. That still drives a lot of decisions, whether anyone will admit it or not. Until we start to deal with the issues of race, we will find ourselves challenged to see the city grow in the manner that it should. People of all diversities will go where the growth is occurring, especially if they have the means to afford the housing.

It would be in the best interest of leadership to find ways to expand the city limits and encourage growth in the few areas that are being overlooked that are already in the city limits. They should also focus on ensuring that existing neighborhoods get the support, services, and upkeep that they need to make them viable areas for growth and sustainability. •

#### **A Dangerous Precedent??**



In the aftermath of the October 15 shooting at Ladd-Peebles Stadium in the closing moments of the Williamson-Vigor football game, there are still numerous questions left unanswered.

The shooting, which left five people wounded, was an event that should have never happened. Scores of people were put in danger because of a reckless act. For those who were involved in the incident, I certainly hope they see their day in court, and are punished accordingly.

What happened at Ladd-Peebles Stadium was bad—very bad. It seems now we have a breakdown in society. In the days after that incident, there were several other shootings, and rightfully, people are up in arms. The recent outbreak in violence prompted Mobile County Sheriff Sam Cochran to step up opposition to a bill that would allow people 18 years of age and over to carry weapons without a permit.

But I'll talk about that another time. Right now, I want to talk about what happened as far as the resumption of the game itself.

When action was stopped with less than six minutes left in the game, Vigor had just intercepted a Williamson pass and had the ball on its own 4-yard line. That's when the shooting began, forcing fans, players, and coaches to take cover. Play was stopped, and there was discussion as to whether to continue the game.

Eventually, an agreement was made with the two schools involved, as well as the Mobile County Public School System, to finish the game. However, it was scheduled for the following Monday at Theodore High School at 10 o'clock in the morning. No fans in the stands were allowed, no students, AND... NO MEDIA.

Here's where the issue lies. Very noteworthy stories were in play here. You had the aftermath of the shooting, as well as the game itself, which was a very important Class 4A, Region 1 contest. Yet, not a single media person was allowed in the stadium. As such, they had to set up camp outside the stadium just to see what was going on.

The question is, why were members of the media not allowed inside the stadium? It was a very important story, regardless as to whether or not there were less than six minutes to go in the game. As it turned out, only one play was run, and the quarterback was allowed, by mutual consent, to run out the remainder of the clock.

Many members of the media who had first-hand knowledge of the situation were concerned about student-athletes being pulled out of class to run one play. Then, there was the gas used to transport students to finish a game at a site clear across the county.

To me, though, it represented the press not being allowed to access a very important event. The official reason was to place an emphasis on safety. However, no members of the working press who were there to cover the game presented no danger to the public, the players, or the officials on the field.

That's why it's very concerning to me. If this is going to be standard operating procedure, then members of Mobile's working press are going to be faced with some serious problems down the road. •


#### City of Mobile to Contribute \$30 Million to Downtown Airport Relocation.

Mobile, AL — The City of Mobile is allocating \$30 million from its general fund budget surplus to assist in the relocation of Mobile's passenger airport to the Brookley Aeroplex. During its meeting earlier today, the Mobile City Council approved a proposal from Mayor Sandy Stimpson to allocate \$30 million to the airport relocation project from a budget surplus that has accrued over the past eight years. Due to sound fiscal policies under the Stimpson administration, the City is able to commit this funding toward the relocation of Mobile's airport without taking on any debt.

"As the Mobile Airport Authority (MAA) continues to lay the groundwork for moving the airport downtown, the City is prepared to help make this game changing transition possible," Stimpson said. "For Mobilians, it will mean more direct flight options and lower fares. Others than the direct benefits for passengers and travelers, it will help seize future tourism and economic opportunities by capitalizing on the synergy that already exists between of the Port of Mobile and the Brookley Aeroplex."

Moving the airport expands Mobile's intermodal capabilities and will allow increased international freight — putting Mobile and the entire State of Alabama on the map as a gateway to North America for moving goods and services. The current airport has a \$570 million economic impact on the City of Mobile and moving the passenger terminal downtown is projected to increase that economic impact to \$1.1 billion.

"To fully fund this effort, MAA will need investment from government partners at all levels," Stimpson said. "While this project is important to the county, state, and the nation, no one will benefit more than the City of Mobile. That's why we are taking the lead on investing in this vital project for our City's future.





#### **What IS Environmental Justice Anyway?!**

The US Environmental Protection Agency defines environmental justice as "the fair treatment and meaningful involvement of all people regardless of race, color, national origin, or income, with respect to the development, implementation, and enforcement of environmental laws, regulations, and policies," and suggests it will be achieved when "everyone enjoys the same degree of protection from environmental and health hazards, and equal access to the decision-making process to have a healthy environment in which to live, learn, and work."

But the phrase "environmental justice" speaks to a long history of grassroots social movements demanding equity and inclusion in community planning and development to assure fair distribution of environmental benefits and burdens.

"Environmental justice" is a response to "environmental racism", which was popularized by a rural black South Carolina community's struggle against the siting of a toxic PCB landfill near their homes in Afton in Warren County. The outrage over that 1982 landfill became the catalyst of the contemporary environmental justice movement when over 500 civil rights and environmental leaders were arrested during a sit-in to halt the landfill's construction.

In 1987, the United Church of Christ Commission for Racial Justice, which had participated in the Warren County PCB landfill protests, released the first nation-wide study to examine how race and income was related to hazardous waste facilities. The landmark study found with virtual certainty what many had long suspected: The racial demographics of nearby communities was a very significant factor in the location of commercial hazardous waste facilities and uncontrolled toxic waste sites.

#### **HEALTH: Where You LIVE Matters More Than Your Income**

Further studies have repeatedly shown that while wealth may be a very strong indicator of health and well being, where someone lives still predicts life expectancy more strongly than income. A more recent study comparing the overall life expectancies of people of equally low and high incomes in New York City with those along the Gulf Coast have made the truth even clearer. Place matters for low income people. Residents of communities across Mobile know this very well. Many residents feel their lives and those of their families have been unfairly impacted by pollution in, around, and traveling through their community.

Africatown is a textbook example. With two interstate highways, a state highway, the region's only contiguous bridge to central Baldwin County, four international railroads, the port railroad, dozens of industrial facilities, concerns about legacy pollution from closed industrial sites, and among the most significant African American histories known to anywhere that implicates the slaver and his descendant families in the community's environmental justice struggle, Africatown is a place where environmental justice is an imperative.

#### **We Must Act Today, for Tomorrow**

Legacies of local, regional, national, and international environmental racism devalues, property, reduces intergenerational wealth, and places the lives of families in jeopardy by locating polluting industry in or facilitating it to and through their neighborhoods through ongoing abuse.

In our efforts to uphold the virtues and to honor the pioneers of the environmental justice movement, the Mobile Alabama NAACP's Environmental and Climate Justice program is committed to righting yesterday's wrongs by standing in the right, today and until "everyone enjoys the same degree of protection from environmental and health hazards, and equal access to the decision-making process to have a healthy environment in which to live, learn, and work."

### National Geographic's Search for Clotilda DNA Would Open An Entirely New Chapter of the Story

Soon it will have been three years since the wreck of Clotilda was found in shallow, muddy river waters about 12 miles north of downtown Mobile.

It is the only ship to have ever been found and professionally validated as having brought enslaved Africans to America.

Since its discovery Africatown, as its now known because that's where survivors of Clotilda decided to settle, has been besieged by film companies from California, to New York, to Georgia, to England and South America, all wanting a piece of the story.

The site of the wreck itself has been under constant electronic surveillance by the state of Alabama since the find to ensure it is not tampered with.

But what's happening with the hulk of Clotilda itself?

Has it just been sitting in the mud near 12 Mile Island with no movement to preserve it? For years, many people around Mobile ... including the family of Timothy Meaher, who is solely responsible for the entire Clotilda saga ... have denied Clotilda even exists.

It was Meaher, if you remember, who made a substantial bet that he could smuggle a load of Africans into America despite it being illegal to do so. The practice had been outlawed by the U.S. government some 50 years earlier and, if caught, the penalty would've been death for him and his other filthy rich cronies.

Evidence inside the wreck shows she was dynamited no less than 40 or 50 years ago in attempt to erase her existence once and for all, and what's now left of the ship rests about 100 yards from a fishing camp owned by –that's right– the Meaher Family themselves.

"We know that National Geographic is at the site and their plan is to draw DNA from the ship's cargo hold, but that's about all we know," said Wendy Lewis, Marketing and Public Relations Director for the Alabama Historical Commission, which oversees any work surrounding Clotilda.

Since the ship was found in Alabama waters the state technically owns all rights to the wreck.

"Other than that, I don't know what Nat Geo is doing," said Lewis.

Lisa Feit, executive producer for National Geographic said it is actually the Walt Disney Company-owned National Geographic Society (and not Nat Geo), that's trying to extract DNA from Clotilda.

"They're trying to get viable DNA from the hold of the ship to determine where in Africa people aboard Clotilda came from," said Feit, who acknowledged that a team of divers will go into Clotilda early next spring to do the actual DNA extraction.

But one thing is certain ... if National Geographic Society is successful in extracting DNA and matching it to swabs of saliva already taken from many descendants almost a year ago, an entire new can of worms could be opened because there would finally be hard evidence of the crime that Meaher, his brother Burns Meaher and friend John Dabney escaped conviction for at trial because of lack of evidence.

Legal scholars have said it would truly be interesting how things could play out in a court of law now, though, if evidence of Clotilda's existence and corroborating DNA was truly proven.

Some argue it could actually open the door for civil litigation against the estates of any and all parties involved in the crime.

If DNA find from the sunken hulk can be successfully pulled out some 162 years after Clotilda's demise, what lies ahead in this deep, dark and secretive saga would just be one more sordid twist to an already intriguing story.

### **NEW GUIDANCE**

#### The Pfizer COVID-19 vaccine has been authorized for children ages 5 - 11.



#### FAMILY HEALTH HAS LIMITED SUPPLY OF PEDIATRIC COVID- 19 VACCINES

The Centers for Disease Control and Prevention (CDC) has recommended pediatric Pfizer-BioNTech COVID-19 vaccine for children 5-11 years of age in the U.S. The COVID-19 Pfizer vaccine for this age group is a reduced dose (10 microgram), two-dose series.

The Mobile County Health Department (MCHD) follows the guidance of the CDC and the Advisory Committee on Immunization Practices (ACIP) regarding vaccination recommendations. The ACIP recommendation applies to all children 5-11 years of age, including those with underlying conditions and previous COVID-19 infection

Family Health, the primary care division of MCHD, has received a limited amount of pediatric vaccine that is available by appointment only (call 251-690-8889 for times and locations). MCHD's new walk-in vaccination and testing clinic at the Festival Centre in West Mobile is not expected to have the pediatric vaccine until at least sometime next week

The Alabama Department of Public Health has provided the following information from the CDC:

- COVID-19 cases in children can result in hospitalizations, deaths, MIS-C (inflammatory syndromes) and long-term complications, such as "long COVID," in which symptoms can linger for months. The spread of the Delta variant resulted in a surge of COVID-19 cases in children throughout the summer. During a 6week period in late June to mid-August, COVID-19 hospitalizations among children and adolescents increased fivefold,
- COVID-19 vaccines have undergone and will continue to undergo the most intensive safety monitoring in U.S. history,
- $\bullet \ \text{Vaccination, along with other preventative measures, can protect children from COVID-19 using the safe}$ and effective vaccines already recommended for use in adolescents and adults in the United States.
- Similar to what was seen in adult vaccine trials, vaccination was nearly 91 percent effective in preventing COVID-19 among children aged 5-11 years. In clinical trials, vaccine side effects were mild, self-limiting, and similar to those seen in adults and with other vaccines recommended for children. The most common side effect was a sore arm.
- Vaccinating children will help protect them from getting COVID-19, therefore reducing their risk of severe disease, hospitalizations, or developing long-term COVID-19 complications,
- Getting your children vaccinated can help protect them against COVID-19, as well as reduce disruptions to in-person learning and activities by helping curb community transmission.


